## May 2023 Program

**Dr. Susan A. MacManus**



Dr. Susan A. MacManus is a University of South Florida Distinguished University Professor Emerita (Department of Government and International Affairs, School of Interdisciplinary Global Studies). From 1998 to 2015, she was a

political analyst for WFLA News Channel 8 (Tampa's NBC affiliate). Since 2016, Dr. MacManus has been the political analyst for ABC Action News (Tampa's ABC affiliate). She is a featured columnist on [sayfiereview.com](http://sayfiereview.com), a widely read Florida-based political website, and has appeared on every major broadcast and cable television and radio network. Dr. MacManus is Florida's most-quoted political scientist. She is not affiliated with any political party.

Dr. MacManus has authored or co-authored numerous publications on Florida politics, including *Florida's Minority Trailblazers: The Men and Women Who Changed the Face of Florida Government*, *Politics in Florida*, *Young v. Old: Generational Combat in the 21st Century?*, and *Targeting Senior Voters*. She and her mother, Elizabeth, also authored two local Florida history books: *Citrus, Sawmills, Critters & Crackers: Early Life in Lutz and Central Pasco County* and *Going, Going, Almost Gone: Lutz-Land O' Lakes Pioneers Share Their Precious Memories*.

Dr. MacManus received her M.A. from the University of Michigan and Ph.D. from Florida State University.

She will give her presentation about local Florida politics on May 3rd, 2023.

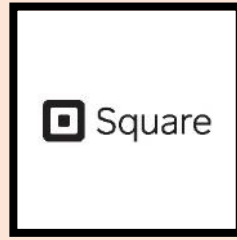
## Surviving Spouse Corner

# Free Lifetime National Parks Passes Are Here for Veterans and Gold Star Families.

All U.S. veterans and Gold Star family members can get a free lifetime entrance pass for federal parks and recreation sites nationwide starting Nov. 11, 2022.

The pass, an expansion on the annual free pass for currently serving troops and their families, grants free access to about 2,000 parks and lands managed by the National Park Service; U.S. Fish and Wildlife Service; U.S. Forest Service; Bureau of Land Management; Bureau of Reclamation; and the U.S. Army Corps of Engineers, according to an announcement on the park service website. It also gives discounted amenity fees in some locations.

While not every park or visitor area requires an entrance fee, many do. For example, Yosemite National Park in California charges a \$35 entrance fee per vehicle, while Craters of the Moon National Monument charges \$20. Other locations charge for entering museum or curation areas in the visitor center. For instance, the Begich, Boggs Visitor Center in the Chugach National Forest, Alaska, charges \$5 per adult to access a film and exhibits.

Those fees are waived for holders of the new lifetime pass, as well as those with the free active-duty America the Beautiful military pass or other passes sold or awarded by the agencies. The new pass covers the holder and any accompanying passengers in a private vehicle at sites that charge per car, or the pass owners and up to three adults age 16 and over at sites that charge per person.

The new lifetime pass program does not exclude veterans with so-called "bad paper" discharges. To get the pass, veterans must submit one of the following:

- Unexpired Department of Defense Identification Card (DD Form 2, DD Form 2765, or Next Generation USID replacement)
- Veteran Health Identification Card (VHIC)
- Veteran ID Card

Veteran designation on a state-issued U.S. driver's license or identification card

To receive a pass visit a National Parks or parks and land agency store or staffed fee kiosk, or order via the [U.S. Geological Survey store](#). Passes ordered online carry a \$10 processing and shipping fee. Passes received in-person are free.

Gold Star family members can receive the pass by presenting a self-verification form certifying they are the next of kin to a military member killed during service overseas. The form includes a signature block and confirmation that the user is an "eligible next of kin (NOK) of a member of the United States Armed Forces who lost his or her life in qualifying situation."

No other identification or proof is required for Gold Star family members who want to get a lifetime pass.

## Legislative Liaison Corner

### May 2023 Update

Dear readers, thank you for your outpouring of condolences regarding the recent passing of my Mom that was highlighted in our April Update. On behalf of myself and my family, we are extremely grateful.

Today's information environment is faster than ever. Even the Military Officers Association of America (MOAA) set up our newly established computer-based online Legislative Action Center at <https://moaa.quorum.us/>. By signing up with this system, you'll have faster access to our legislators. I tested this system recently, and it was quite successful. Here's an encouragement to sign up and participate.

Recently funerals for veterans in Florida became an issue. Let's be best informed on our rights regarding funerals.

The Florida Department of Veterans Affairs (FDVA) has a wonderful website, <https://floridavets.org/benefits-services/burial/>, where we can learn about our rights to funerals as veterans. What follows is taken from this site.

The U.S. Department of Veterans Affairs

provides honorably discharged veterans, spouses, and dependents with burial in a National Cemetery at no cost. Cremated remains are also accepted. Eligible spouses and dependents may be buried if they predecease the veteran. The VA does not make funeral arrangements. To make burial arrangements at any open VA national cemetery at the time of need, call the National Cemetery Scheduling Office toll-free at (800) 535-1117.

The VA also provides eligibility determinations for interment in a National Cemetery before the time of need. Upon request, individuals can learn if they are eligible for burial or memorialization in a VA national cemetery through the Pre-Need Determination of Eligibility Program. Florida has nine National Cemeteries (Barrancas National Cemetery in Pensacola, Bay Pines National Cemetery in St. Petersburg, Cape Canaveral National Cemetery in Mims, Florida National Cemetery in Bushnell, Jacksonville, Sarasota, South Florida National Cemetery in Lake Worth, St. Augustine and Tallahassee).

The benefits available for veterans buried in a private cemetery may include a Government headstone, marker, medallion, burial flag, and a Presidential Memorial Certificate, at no cost to the family. Some veterans may also be eligible for Burial Allowances. No VA benefits are available to spouses and dependents buried in a private cemetery. The VA does not make funeral arrangements.

## Peace Officers Memorial Day – May 15, 2023

A Peace Officer is a public-sector employee whose duties primarily involve the enforcement of laws. They include police officers, sheriffs, agents of state and federal departments, and many more. Peace Officers Memorial Day falls on May 15 each year to pay tribute to the brave local, state, and federal peace officers who have died or been disabled in the line of duty. The day is marked with a memorial event in Washington D.C., a candlelight vigil, and speeches commemorating officers past and present. In October 1962, President Kennedy signed the Bill that designated May 15th as Peace Officers Memorial Day. The first celebration of this day was in May 1963. In 1994, President Clinton directs, through Public Law, that the United States flag be flown at half-staff on May 15th to honor the day. The nation's monument to law enforcement officers that have died in the line of duty is the National Law Enforcement Officers Memorial in Washington, DC., and was dedicated on October 15, 1991. The Memorial features two long curving blue-gray marble walls. Carved on the walls are the names of 23,800 officers who died in the line of duty throughout U.S. history, dating back to the first known death in 1786. In 2022, there were 224 Peace Officer deaths.

Public peace officers began in the mid-1600s, first in Boston and then in New York and Philadelphia. They were predominantly volunteers who acted as night watchmen. Boston continued to lead the way in peace officer organization, with the first publicly funded, organized police force set up in 1838, which paid officers to keep the peace full-time. By the late 1880s, all major U.S. cities had police forces. Law enforcement heads were often chosen by the local political leader so, as a result, the enforcement could work in favor of the ruling political party. In response, President Hoover set up an investigation into the effectiveness of law enforcement nationwide in 1929. It called for peace officers to work in a professional and impartial way to enforce the law and was a turning point in the history of the officers who protect us today. It promoted the dedication and sacrifices that we now honor every year on May 15th. Some ways to celebrate the Day include:

- 1) If you have a U.S. flag at home, fly it at half-staff or half-height as a matter of respect.
- 2) Light your windowsill with candles (suggest electronic vs. burning candles) for officers injured or that lost their lives.
- 3) If feasible, replace the bulb in a front door outside light or a lamp post with a blue bulb.
- 4) Support peace officer charities, whether it is a donation of time, money, food, or clothing.
- 5) Thank peace officers for all they do to help keep your community safe.

# International Firefighters' Day – May 4, 2023

International Firefighters' Day (IFFD) is observed on May 4. It was instituted after a proposal was emailed out around the world on January 4, 1999, due to the deaths of five firefighters in tragic circumstances in a bushfire in Australia. The date of May 4 relates to Saint Florian, regarded in the Catholic Church as the patron saint of firefighters. The saint's day (as observed by the Catholic Church) of St. Florian is 4 May, hence IFFD is also observed on May 4. International Firefighters' Day is a time where



the world's community can recognize and honor the sacrifices that firefighters make to ensure that their communities and environment are as safe as possible. It is also a day in which current and past firefighters can be thanked for their contributions.

Often communities remember human sacrifice through observing a minute's silence. For International Firefighters' Day in 2002 the inaugural "Sound Off" was conducted to reflect on the commitment and sacrifices of firefighters' worldwide in a truly poignant manner for emergency service workers. Due to the amazing support of the Sound Off in 2002, there is now an annual Sound Off on the first Sunday of every May. That is a special time to stop and reflect on the sacrifices made by firefighters. At noon local time on that first Sunday in May, fire sirens sound for 30 seconds followed by a minute's silence in memory of, and respect for, all firefighters who have been lost in the line of duty or passed on before us. This is known as the "Sound Off."

We can show our support and appreciation to the firefighters worldwide who continue to protect us so well throughout the year. By proudly wearing and displaying blue and red ribbons pinned together or by participating in a memorial or recognition event, we can show our gratitude to firefighters everywhere. The IFFD ribbons are linked to colors symbolic of the main elements firefighters work with – red for fire and blue for water. These colors are also internationally recognized as representing emergency service.
