Donald Gunn is in his tenth year as an instructor for the Army Junior Reserve Officers Training Corps (JROTC) program. where his parents were born and across the street from his grandfather's orange grove. He is currently the Senior Army Instructor at Brandon High School where he was the cadet battalion commander 36 years ago.

Attending the University of Tampa on a 4-year Army ROTC scholarship, Colonel Gunn graduated Magna Cum Laude in 1990 with a commission as a second lieutenant in the Regular Army. Upon entering active duty he immediately deployed to Operation Desert Storm with the 101st Airborne Division. 

Her specialties and topics of expertise include campaigns and elections, redistricting, women & minorities in politics, election reform, media and politics, public opinion polls, government budgeting & finance, Florida politics—all levels, intergenerational issues, and public policies.

For the last 30+ years, this University of South Florida Distinguished University Professor (Political Science) Emerita has been a fixture in Florida politics. She's had a front-row seat to some of the most significant political events in the state's history – using that insight and knowledge to educate her students and people worldwide. For the better part of two decades, MacManus has been Florida's most-quoted political scientist, usually the first person called by national and local news operations for information and perspective on state politics. She retired just a few years ago from teaching after 45-plus years in the classroom, 30 of those at the University of South Florida in Tampa as a distinguished professor in the Department of Government and International Affairs. Though retired, she continues analyzing Florida's demographics and voting patterns.

first permanent resident of Lutz, north of Tampa. She still lives in his nearly 100-year-old home. She became a media go-to for her data-based, nonpartisan analyses and insights on politics and because she gave generously of her time. During the George W. Bush-Al Gore election, when Florida's notorious "hanging chads" prompted a recount, MacManus told Fox 13 News she went 36 hours without sleep as news outlets worldwide struggled to understand the problems.


## Yellow Dot Program Update Ferris Garrett

Hillsborough County's Yellow Dot program gives you a voice if you are seriously injured in a vehicle accident or experience a medical emergency while driving. You may be disoriented, in shock, or unconscious and cannot communicate when help arrives. A round Yellow Dot sticker on the driver's side of the rear window alerts rescue personnel that vital personal and medical information is on a form in the glove compartment. The Form identifies who you are, your current medications, medical history and any conditions that affect your ability to communicate. This information is confidential in nature and helps rescue personnel in determining your treatment. The information you provide can help save your life. The cities of Tampa, Plant City, and Temple Terrace emergency services also participate in the Hillsborough County Yellow Dot program.

The Yellow Dot sticker is placed on the driver's side of the rear window and the filled-out form, with your attached photo, is placed in the glove compartment. More information and instructions are available on-line at <u>www.HCFLGov.net/</u> <u>YellowDot</u>. Presently, Yellow Dot stickers and information cards are not available at Hillsborough County Fire Rescue Stations. To obtain Yellow Dot materials, you can send an email to: <u>HCFRPublicRElations@HillsboroughCounty.org</u> and Fire Rescue Headquarters will mail these materials to you. You can also call Ferris Garrett (813 -841-0532) for information, and he has Yellow Dot Stickers & Information Cards available.

If you are interested in the program, please Email him at: <u>garrett4@tampabay.rr.com</u> with your name and mailing address and Yellow Dot materials will be mailed you. In the Email, please note if you have another vehicle and if there is a <u>second driver</u> or a <u>frequent passenger</u> in your vehicle(s), for example, a Spouse, other relative, or friend. Your yellow Dot materials will include a second Sticker and/or additional Information Card(s) to be filled out by another driver or passenger, to be stored in the glove compartment with your Card. These same guidelines will also apply if you send your email request to Fire Rescue Headquarters.

Please discuss the Yellow Dot program with friends and neighbors. Home/Property Owner's Associations may have means of communications with association residents through email groups or, possibly, newsletters or membership meetings. Recommend contacting the Association Board and ask if this Yellow Dot information article could be forwarded to the residents, in the interest of public safety. #### With War Raging in Eastern Europe, Will Con- MOAA President Sounds Warning on Benefit gress Finally Fund Our Government? **Cuts in 'The Hill' Commentary**

With a continuing resolution (CR) slated to expire March 11, both chambers must resolve differences to pave the way to appropriate funds necessary to sustain the government for the rest of this fiscal year.

The most recent CR, H.R. 6617, made it through the House on Feb. 8 with little trouble. But the Senate was slow to act, held up by a handful of COVID-related amendments that would have derailed the process. Sensing the president was ready to sign the bill, Senate leaders shut down the amendments and moved to a vote; the measure passed Feb. 17, just one day from the government shutdown deadline. Will there be resentment from those who want to continue waging efforts to get their COVID-related amendments into the full appropriations or the next CR? Will other emerging issues find their way into the appropriations process? The answers will hopefully be known well before March 11.

However, it is more likely we will see one of three results, and likely just at the deadline:

- 1. Congress passes full appropriations through the fiscal year.
- 2. Congress passes modified appropriations through the fiscal year.
- 3. Congress submits yet another CR to allow more time to resolve differences.

Given the three CRs already this fiscal year, the narrowing window of opportunity, and the competing priorities within both parties in an election year, there is little cause for overwhelming optimism that both chambers collectively will solve the biggest question: "Will Congress fully fund the government?"

Our country sent troops to Eastern Europe they are stationed around the war in Ukraine as a show of support for our NATO allies. Make no mistake, our service members are in harm's way. War is difficult to contain — especially when the leader of Russia already has shown a disregard for borders and the lives of innocents. Ask your lawmakers to show support for those under threat and for all members of the uniformed services community, past and present, by passing a budget now.


Just months after the end of the war in Afghanistan, and despite the massive buildup of forces in Europe, signs point to pressure on lawmakers to cash in some of the "peace dividend" at the expense of servicemembers, veterans, and their families and survivors. Instead of appreciation for the uniformed services community, such talk is "creating a much different, unsettling message," wrote Lt. Gen. Dana T. Atkins, USAF (Ret), MOAA's president and CEO, in a Feb. 9 commentary published by The Hill.

That message: "Thank you for your service and sacrifice, especially after two decades of war, but we need to cut your pay and benefits to modernize." Atkins addresses the "false choice between bullets and benefits" offered in some corners to justify increasing materiel budgets while leaving personnel accounts flat ... or worse. While this narrative poses a threat to the benefits earned through service, it's not a new fight, Atkins points out, highlighting budget-driven moves made in the last decade such as:

- The "pay gap" from 2014 to 2016 short-• changed servicemembers and will cause ripple effects in retirement compensation for decades.
- Increases to TRICARE pharmacy costs and program fees outpacing retiree cost-of-living adjustments.
- The Blended Retirement System, which will reduce the value of a 20-year military career and cost DoD less money, with unclear results beyond readiness issues, as "midcareer service members consider leaving early — and taking their wealth of experience out the door with them," Atkins wrote.

Only by engaging on these efforts to lessen benefits now will the uniformed services community avoid similar actions in coming years, especially in the face of inflationary pressures and other fiscal threats. "Our economy may fluctuate," Atkins wrote, "but our resolve on behalf of service members cannot." MOAA will mobilize this spring for its annual advocacy campaign, with an eye toward protecting military pay along with other critical legislative objectives.
