From the Editor's Desk CDR Cliff Korn, USNR (Ret)

Our Fearless Leader, Bill Kirkpatrick is under-the-weather and unable to give a President's Report this month, so I am usurping his space! Let's all pray that Bill is feeling better soon.

Not all veterans are eligible for health benefits through the VA. Although I am retired, I do not have service-connected disabilities and therefore fall into this category. Despite this, I have never felt discriminated against, as Medicare and Tricare for Life have adequately met my family's needs. However, I became somewhat dissatisfied when I required hearing aids and observed that many of my fellow retirees were receiving top-of-the-line aids at no cost from the VA. For civilians, there is an array of options for purchasing hearing aids, but quality devices can easily exceed \$6,000 per pair.

A beneficial solution for military retirees is available through the Retiree At Cost Hearing Aid Program (RACHAP). This program allows military retirees and dependents who are ineligible for hearing aids from the Veterans Administration (VA) to purchase them at a reduced cost through certain military treatment facilities. While RACHAP operates on a "space-available" basis and is not covered by TRICARE or Medicare, patients pay the manufacturer directly. The Defense Department's RACHAP facilitates the acquisition of hearing aids at government-negotiated prices via specific military medical facilities.

Retirees can utilize any military treatment facility offering the program and are not restricted to their service affiliation. It should be noted that not all military medical facilities participate in this program, as the care of active-duty members takes priority. Unfortunately, MacDill Air Force Base does not offer this program; the nearest participating facility to the Tampa area is Naval Hospital Jacksonville at NAS Jacksonville. Upon moving to Florida in 2012, I found that only active-duty personnel were being serviced at NAS Jax, prompting me to travel to Lyster Army Health Clinic in Fort Rucker, AL to benefit from RACHAP. While the additional travel and lodging expenses may be considerable, they are often deemed worthwhile. Currently, I have new hearing aids on order and will be returning to NAS Jacksonville in a few weeks for fitting and counseling on use. The cost for a pair of advanced, high end hearing aids suitable for my profound hearing loss is only \$941, which I find well worth the travel.

Chaplain's Devotional for January

God's Immutable Law

"While the earth remains, seedtime and harvest, and cold and heat, and summer and winter, and day and night shall not cease." (Genesis 8:22).

Genesis 8:22 reminds us that our universe is governed by immutable laws put in place by God. The Scripture cites four life-long examples of God's unchanging constitution: seedtime and harvest, cold and heat, summer and winter, and day and night. We take for granted the changing of the seasons that produce crops, the cold of winter and heat of summer, or day for service and night for rest.

Our Scripture reminds us of another unchangeable law of life, the law of sowing and reaping (Galatians 6:7-9). How often have you heard the proverb, "you reap what you sow." There are four principles the immutable law of sowing and reaping make clear to us. Let's talk about that today. **Principle #1: You reap what you sow.**

If you sow a watermelon seed, what do you get? A watermelon. If you sow a kernel of corn, what do you get? Corn. If you sow love, joy, peace, patience, gentleness, goodness, faith, meekness, and self-control, what do you get?

God's immutable law guarantees you will reap the benefits of sowing into the life of others.

Principle #2: You will reap in greater proportion that what you sowed.

How many watermelons come from planting one seed? How many kernels of corn? God alone knows the answer. God alone knows the impact we can have every day as He places divine appointments in our way. The question is, "What will I sow in the lives of those I meet daily?"

Principle #3: You may not always reap in the same season.

Sowing good fruit in faith gives us comfort that God will reward our efforts. His divine providence may reward us before the growing season is completed and harvest time arrives. God know our need and is bound by Scripture to cause us to reap what we sow.

Principle #4: Don't grow weary in doing good. You will reap in due season.

Planting is hard work. It is easy to grow weary as we look at the pressures of life. Know from Scripture that God will cause us to reap what we sow. What are you planting today? That is what you will reap in the future. Be abundantly blessed, Rev. Dr. Tom Smith



Veteran Overmedication and Suicide Prevention Act

Lawmakers are renewing efforts to address potential overmedication of veterans by Department of Veterans Affairs (VA) doctors, a concern linked to increased suicide rates among former service members. The proposed "Veteran Overmedication and Suicide Prevention Act" seeks a comprehensive study to examine the types and quantities of medications prescribed to veterans, the prevalence of non-pharmaceutical treatments offered prior to medication, and the frequency of medications being the initial treatment option. This initiative aims to identify patterns in prescription practices and their possible connections to veteran suicides, with the goal of improving mental health care and reducing reliance on pharmaceuticals within the VA system.

Proposed Veteran Legislation in Florida

As of February 2025, Florida has introduced several legislative measures to support veterans:

- **Senate Bill 116**: Filed on February 5, 2025, this bill mandates the Florida Department of Veterans' Affairs to conduct a study evaluating veterans' awareness of existing programs and services. It also aims to enhance the Veteran Suicide Prevention Training Pilot Program by incorporating specialized mental health training and proposes the development of adult day health care facilities for veterans and their families.
- **House Bill 445**: Filed on February 6, 2025, this bill seeks to exempt certain disabled veterans from paying tolls on Florida's toll facilities.

In the previous year, Governor Ron DeSantis signed House Bill 725 into law, expanding eligibility for admission to state veterans' long-term care facilities to include spouses or surviving spouses of qualifying veterans. Additionally, House Bill 1329 was enacted to enhance programs and benefits for veterans, such as designating "Veterans Florida" as the state's primary contact for military transition assistance and creating a fee exemption on hunting and fishing licenses for honorably discharged veterans with qualifying service-connected disabilities.

Pay Raise for Military Retirees and Active Duty

Congress has approved a pay increase for military retirees in 2025 through a 2.5% Cost of Living Adjustment (COLA), effective December 1, 2024. This adjustment is based on the Consumer Price Index and aims to account for inflation. Retirees saw this increase in their December 31, 2024 payment.

It's important to note that COLA adjustments for retirees differ from the annual pay raises for active-duty service members. While active-duty personnel received a 4.5% pay raise in 2025, with junior enlisted ranks (E-1 through E-4) receiving a total increase of 14.5%, these raises are separate from the COLA adjustments applied to retirement pay.

Veteran's Affairs Welcomes New Secretary

As of February 7, 2025, the Department of Veterans Affairs (VA) has undergone significant leadership changes and is implementing new policies to enhance services for veterans. On February 4, 2025, the U.S. Senate confirmed former Georgia Representative Doug Collins as the new VA Secretary with a 77-23 vote. Collins, an Air Force Reserve colonel and military chaplain, has pledged to streamline regulations and combat corruption within the VA to ensure veterans receive their due benefits. Additionally, the VA has announced a return to in-person work policies starting February 3, 2025, aiming to improve service delivery and accessibility for veterans. These developments reflect the VA's ongoing commitment to enhancing care and support for the approximately 18 million veterans it serves.

Buchanan Hosts Inaugural Valentines for Veterans

Buchanan and Team Delivered Over 4,000 Valentines Card to Area Veterans



2/14/2025 BRADENTON — Today, Congressman Vern Buchanan delivered handwritten valentines cards to local veterans <u>at the Manatee County Sheriff's Office and the Manatee County Commission</u> through his new constituent appreciation program, Valentines for Veterans. He also discussed a new package of pro-veteran legislation he rolled out this week to help improve the mental and physical health of America's veterans.

"Seeing the smiling faces of our incredible veterans when they were handed a card was the reason I started this program," said Buchanan. "It was also great seeing such great artwork from our students who put a ton of thought and care into each one of these cards. I'm grateful for our school systems' participation and their work helping me honor the sacrifices made by our veteran community. Their service and sacrifice will never be forgotten."

Buchanan partnered with 26 local schools and youth organizations in Manatee and Hillsborough Counties to create more than 4,000 cards for veterans living in Florida's 16th Congressional District. There are over 64,000 veterans living within the District and this new program intends to reach as many as possible with a valentines card to thank them for their service.

Schools and youth organizations participating include: Alafia Elementary School, Bayshore Elementary School, Blackburn Elementary School, Boys & Girls Clubs of Manatee County, Braden River Middle School, Corr Elementary School, Doodle Bugs! Children's Learning Academy, Dr. Mona Jain Middle School, G.D. Rogers Garden-Bullock Elementary School, Gene Witt Elementary School, James Tillman Elementary School, Lakewood Ranch High School, Lakewood Ranch Preparatory Academy, Manatee High School, Nelson Elementary School, Oneco Elementary School, Palm View K-8 School, Palma Sola Elementary School, Palmetto High School, Pinecrest Elementary School, Ruskin Elementary School, Summerfield Elementary School, Thompson Elementary School, Tillman Elementary School, Trail Life Troop and Virgil Mills Elementary School.

In addition to veterans working at the Manatee County Sheriff's Office and with Manatee County, Buchanan and members of his staff personally delivered valentines to: the Bradenton Fire and Police Departments, the East Manatee Fire District, Freedom Village Veterans, the Longboat Key Police and Fire Departments, Manatee County Bob's Vets, the Manatee County Veterans Council, MOAA Sun City Center, the North River Fire District, the Sarasota Police Department and other veterans organizations.

Buchanan Delivers Remarks on New Veterans Legislation

Bills Establish Program for Medically Tailored Meals, Support Veterans Experiencing Mental Health Crises



2/14/2025 BRADENTON — Congressman Vern Buchanan delivered brief remarks on new legislation he introduced to fight for Florida's veterans, the <u>Veterans Nutrition and Wellness Act of 2025</u> (H.R. 1289) and the <u>Vet-</u> <u>erans Mental Health Crisis Referral Enhancement Act of 2025</u> (H.R. 1290).

"With more than 64,000 veterans in our district, fighting for our veterans and America's servicemembers has been one of my top priorities since coming to Congress," said Buchanan. "Our nation's veterans have sacrificed so much for our country, and we must ensure they have access to the nutritious food and mental health care they need to stay healthy."

The Veterans Nutrition and Wellness Act of 2025 offers enhanced nutritional food options to veterans through a "food as medicine" health care approach. The bill directs the Secretary of Veterans Affairs to establish and carry out a pilot program to administer medically tailored meals and groceries to eligible veterans.

The Veterans Mental Health Crisis Referral Enhancement Act of 2025 addresses critical gaps in mental health care for veterans. This bill directs the Secretary of Veterans Affairs to establish a three-year pilot program to refer veterans experiencing mental health crises to approved non-Veterans Affairs mental health care providers, ensuring timely access to competent care.

Buchanan has fought for veterans and America's servicemembers throughout his career. In January, he introduced the *Veteran Overmedication and Suicide Prevention Act* (H.R. 136), which requires the Department of Veterans Affairs to review the deaths of all veterans it treated who died by suicide or from a drug overdose in the last five years.
